Minutes of the Meeting held on Thursday 9th January 2019 at 6.30 pm at Bedlington Community Centre, Bedlington.

OPEN SESSION

- A resident asked if the new play area at Church Lane was complete and outlined a number of concerns in relation to the quality of the safety surface and the need for access path.
- A resident support the previous comments in relation to the new play area at Church Lane and additionally advised about the need for litter bins, adjustments to the access gates and the exclusion of dogs from the play area. The Chair thanked both residents for their constructive comments and advised that the Council will revisit all of these suggestions at its next Services Committee meeting and look to make the required improvements.
